They present brief synopses of newspaper articles, identify the newspaper -- Eagle, Beacon or Eagle-Beacon -- in which the stories first appeared, and give exact references to the pages on which the articles are found. Microfilmed copies of these newspapers are available at the Wichita State University Libraries, the Wichita Public Library, or by interlibrary loan from the Kansas State Historical Society.

4. Article says the contract for the new (i.e., enlarged) Sedgwick county court house has been let to Mr. Abe Smith for \$13,586. Details. Messrs. **Terry** and Dumont are the architects.

Tuesday, July 21, 1885

page

4. The design for the building of R. C. Noble, to be erected on the northeast corner of Douglas and Topeka, is now completed by the architects, **Terry** and Dumont. To be three stories with front of St. Louis pressed brick.

Wednesday, September 16, 1885

1. Long article describes the newly enlarged county court house. **Terry** and Dumont, architects. Abe Smith, contractor. Cost \$22,500. To be completed by October 1st. Details.

Monday, December 21, 1885

4. Architects **Terry** and Dumont have finished the plans for a two story brick residence to be erected by Mr. J. A. Jones at 10th and Lawrence.

Friday, April 16, 1886

page

4. Messrs. **Terry** and Dumont have just finished the plans for a magnificent residence for Mr. Robert Black, proprietor of the Manhattan hotel. The home will be 48 by 63 feet, and built on corner of Douglas and Hydraulic avenues.

Thursday, April 22, 1886

4. Contract was let yesterday by **Terry** and Dumont for foundation for the new residence

of W. K. and L. L. Carlisle on Topeka avenue.

Terry and Dumont, architects, received instructions today to make plans and specifications for the new brick blocks of Hacker and Jackson and H. J. Friend, which are to be erected on Douglas avenue near the Exton block. The new blocks are to be 100 by 110 feet, three stories high, with fronts of solid cut stone.

Report of visit to several busy Wichita architects. Terry and Dumont have about finished plans and specifications for the new business houses of Hacker and Jackson and Friend, which will be built in "union" on the corner of Douglas and 4th avenues. It will extend from the Exton block on Douglas 100 feet to the corner and then back 110 feet on 4th avenue. It will be three stories, of St. Louis red brick, trimmed with Cottonwood Falls cut stone. This firm have also just finished the plans for Attorney Charley Hatton's \$3500 residence to be erected on Waco between 1st and 2nd streets.
 ¶ Architect C. W. Kellogg has just completed the plans for Aldrich and Hodgson's new three story business block on North Main, to be erected on site of the burnt district between 1st and 2nd streets. It will cost about \$12,000.

4. **Terry** and Dumont are drawing the plans for Mr. Sam Majors' new residence on North Topeka avenue.

4. Architects **Terry** and Dumont are completing the plans and specifications for Mr. Finlay Ross' magnificent new residence to be erected on North Waco at cost between \$10 and 15,000.

4. Architects **Terry** and Dumont are finishing the plans for a new city building, which is to be erected on the lots owned by the city on Market street where the present calaboose is situated. The building is to be 25 by 80 feet, two stories, of brick with stone trimmings. The first floor will be used as a hose house with two stalls for five horses, while the second floor will be used as a council chamber and city offices.

1. Architect **Terry** has the plans for the John Bright university nearly completed. The foundation is already completed. The superstructure will be 88 by 168 feet and three stories high.

Monday, January 7, 1889

1. C. W. **Terry** is constructing a residence for C. K. Freeman on College Hill.

Tuesday, June 17, 1890

 Board of education yesterday let contract for building of College Hill school house to William Dunscombe for \$6109. ¶ Building committee recommended plans of C. W.
 Terry for the proposed addition to the high school, and this was accepted.

Tuesday, July 8, 1890

page

1. School board yesterday accepted bid on the high school addition of \$5370 by J. H. Nixon. It was \$972 above the estimate by the architect, but the contractor argued that the estimates were made too low by the architect, C. W. **Terry**.

Wednesday, April 4, 1894

4. The new auditorium construction will begin shortly according to plans of Architect **Terry**, although the building will be put up without a stage until an additional \$1,500 is forthcoming from the subscribers.

Saturday, April 14, 1894

4. Contract was awarded this morning to William Borden of this city for construction of the new auditorium according to the plans of architect C. W. **Terry**. Building will be 116 by 138 feet and over 76 feet high at the pinnacle. A large center dancing space on the first floor will be 80 by 96 feet. Cost is about \$5,000 without the stage, which will

be added later. Work should start Monday and construction will take about 35 days.

5. C. W. **Terry**, architect, inspected the old Johnston-Larimer building today with a view to remodeling the building for the Elks, who intend to make a temple of the structure. The Johnston-Larimer company is moving out of the building into their new place of business.

5. Report of board of education meeting yesterday which awarded Architect C. W. **Terry** \$100 for the plans thought most suitable for a new high school building. These are only rough plans from which the board can advertise the building which it wishes to erect.

Plans will be finished April 15 for the \$30,000 Emporia Avenue addition to St. Francis Hospital. Architect is C. W. **Terry**. To be three stories, brick, and front 115 feet on Emporia and extend back 91 feet to the main building. Will have 75 rooms.

about November 1, according to Architect C. 4. City council yesterday; plans submitted by **Terry** and Dumont, architects, for the new fire station building. Estimated cost \$4,600. Clerk to advertise for bids.

Sunday, November 7, 1886 page

4. The architectural firm of **Terry** and Dumont has been changed to Dumont and Hayward. Hayward is a young man from Cincinnati.

Thursday, January 20, 1887

page

4. The firm of Gould and **Terry** are drawing plans for a residence for Mr. J. O. Davidson which will cost near \$20,000. It will be located on Riverside ave. in Riverside addition, with a front of 88 ft., 50 ft. deep, and three stories high. The stairway in both upper and lower hall is lighted by a pane of stained glass 7 x 15 ft. In the third story is the billiard hill which is 15 x 31 ft. Work will be commenced next spring.

4. The architect firm of Gould and **Terry** has dissolved.

Wednesday, March 16, 1887

4. The Rock Island yesterday bought property south of Douglas ave. and facing on the ave. for \$54,000, presumably to be used for a passenger depot.

Plans for the William Fletcher building on northwest corner of Main and 2nd have been completed by architect **Terry**. To have 50 ft. front on Main and 150 ft. on 2nd, four stories. Excavating has been completed and work will start soon. Details.

Wednesday, May 11, 1887

4. Architects **Terry** and Thompson have completed plans for Kansas Midland depots to be erected at points three and six miles north of Douglas ave. Each will be near 40 ft. long and 20 ft. wide and surrounded by platform extending 14 ft. from the building, and will be covered by dimension shingles. The contract for both buildings has been awarded and they are expected to be completed by the first of next month.

Henry Schweiter and Joseph Mossbacker (sic) propose to erect a brick business building on Douglas ave. adjoining the Noble block. It will have a front of 50 ft., be 135 ft. deep and four stories high. Architects **Terry** and Thompson are drawing the plans. The block will cost near \$50,000.

Architects **Terry** and Dumont were awarded the contract for preparing plans for the building of the John Bright university. There will be three buildings in all, in modern gothic style. The main building, to cost about \$75,000, will have a front of 162 ft. and be 85 ft. deep and three stories high with basement. The foundation will be of Cottonwood stone extending six feet above ground. St. Louis pressed brick will be

used for the entire building. ¶Excavating for the main building is progressing nicely and the contract for the foundation will be awarded next week.

Contract signed yesterday with Wurster Construction company to erect a six story building at southeast corner of Douglas and Main, the entire structure to be occupied by Wallenstein and Cohn with a large department store. To cost approximately \$175,000. Work to be started August 1 and the building completed by March 15, 1907. ¶ The Boston store building now standing on this property will be torn down. The new building will have frontage of 90 feet on Douglas and 120 feet on Main. ¶ Plans for building drawn by C. W. Terry, architect.

Full page article describing the decorative splendor of Wichita's Scottish Rite Cathedral, the improvements of which were begun in February 1907 and will be completed about June 1st at a cost of about \$175,000. ¶ More than a million of Coffeyville brick were used in the new portion of the building, and for the Topeka avenue front of the building several hundred tons of Towanda stone were used to harmonize with the material in the original building. ¶ Architect was C. W. Terry of Wichita, with the associate architect Mr. Charles Thompson, of Little Rock, Arkansas. ¶ The great organ was built by M. P. Moller, of Hagerstown, Maryland. ¶ The old YMCA building at 1st and Topeka was purchased in January 1898.

Mead, a founder of Wichita, who died three years ago.

5. Contract let yesterday by J. L. (Bunnie) Mead of Chicago for new three story building at 412-414 East Douglas to cost about \$36,000. Work will start at once and be completed by September 1. Building is 50 by 140 feet, with a front of terra cotta. Work of razing the present building on the site will start this week. C. W. **Terry** is the architect. The front of the building will be similar to that of the building at 506 East Douglas, which was remodeled by Mr. Mead last year.

6. Article on history of the Auditorium at 1st and St. Francis, recently condemned and to be razed. A campaign in the hard times winter of 1895 raised money for the \$12,000 building, designed by C. W. **Terry**, architect, but it did not make expenses and was mortgaged and eventually sold to Colonel H. G. Toler.

5. Article reports death early last week of C. W. **Terry**, age about 80, pioneer Wichita architect, at his home in Alhambra, California, where he had moved about ten years ago. Among other buildings he designed the Boston store and the Barnes building.
