Dr. Edward N. Tihen (1924-1991) was an avid reader and researcher of Wichita newspapers. His notes from Wichita newspapers -- the "Tihen Notes," as we call them -- provide an excellent starting point for further research. They present brief synopses of newspaper articles, identify the newspaper -- Eagle, Beacon or Eagle-Beacon -- in which the stories first appeared, and give exact references to the pages on which the articles are found. Microfilmed copies of these newspapers are available at the Wichita State University Libraries, the Wichita Public Library, or by interlibrary loan from the Kansas State Historical Society.

On it is the passenger station, the freight depot and office building, and the shops of the Interurban company, which will remove its tracks from the property and give possession by July 1, 1920.

2. The Golden Rule Refining company yesterday bought the Interurban property at the northeast corner of 1st and Water streets for \$42,000. The property is 125 by 140 feet, consisting of the two story brick office building, the passenger and freight station, and the car shops. ¶ The refining company expects to get possession July 1 after the Interurban moves to its new location at Douglas and Waco. They plan to build a new filing station and add another story to the present office building on the property.
