Dr. Edward N. Tihen (1924-1991) was an avid reader and researcher of Wichita newspapers. His notes from Wichita newspapers -- the "Tihen Notes," as we call them -- provide an excellent starting point for further research. They present brief synopses of newspaper articles, identify the newspaper -- Eagle, Beacon or Eagle-Beacon -- in which the stories first appeared, and give exact references to the pages on which the articles are found. Microfilmed copies of these newspapers are available at the Wichita State University Libraries, the Wichita Public Library, or by interlibrary loan from the Kansas State Historical Society.

# Wichita Beacon Wednesday, January 1, 1908

page

- 6. Superintendent Morrison of the street car company said yesterday that beginning today no more complimentary transportation would be issued by the company in this city to anyone. He understands that the provisions of the state anti-passenger law (i.e., one directed mainly at steam railroads) include street car companies as well as steam railways and he does not want to get into trouble. This means that employes of the street car company will have to pay their fare, that city officials will receive no more green tickets, and that newspaper reporters will have to pay their fare in coin or go by foot.
- 8. Because of an accident the Orient Railroad track was four miles from the Texas border at the deadline, midnight last night, but because they have shown good faith in trying to complete the line to this point on time Wichita citizens are inclined to overlook this. \$80,000 in bond and was voted in 1901, with the line to be completed to the Texas line by January 1, 1906, but when this became impossible, a two year extension of the time was granted. Details.

Report of death of B. H. Campbell early today aboard a train en route from Mexico City to San Antonio, accompanied by his daughter, Eleanor. Born in western New York about 80 years ago. Married first wife in New York and had one son by this marriage. Both wife and son died in northern Illinois. Married second wife while still in Illinois, and she died here last spring. Moved to Texas about 1860. Came to Wichita about 1880 and purchased a home at 345 North Lawrence. He purchased an interest in a local street car line in Wichita when mule cars were in vogue. Through his efforts the line was extended largely. He later engaged in the cattle business in Indian Territory, which he abandoned when the territory was opened to settlement. In 1887 during the "boom" he sold his interest in the street car line, and in about 1887 he purchased a ranch of about 18,000 acres in Clark County, about 20 miles northwest of Ashland. The proceeds made him wealthy, and in 1887 he built a stone mansion in Riverside, which he still occupied as his home. Three children were born to his second wife, two of whom are still living, a daughter Eleanor C., and a son, Robert B. The other son, Charles, was killed by being thrown from a horse six years ago.

- Mr. A. A. Hyde has announced plans for a new reinforced concrete building for the Mentholatum company (actually the Yucca company, manufactures of Mentholatum), to be built at northeast corner of Cleveland and Douglas at cost of between \$12-15,000. To be 75 feet wide and 110 feet long. The factory of the concern is now located in a building at 1211 East Douglas. Architect for new building is U. G. Charles. Details.

Superintendent Morrison of the Wichita Railroad and Light company reports that in the year 1907 the company's cars traveled a total distance of 1,329,000 miles. The average distance traveled each day by a car on the Wichita system is 170 miles. ¶ He stated that requisitions have been made by the Wichita office for \$88,838 worth of improvements for the present year, mainly for material to be put into new tracks. The largest item is for steel. It seems probable there will be a demand for paving of North Topeka avenue before long, and the street car company wishes to have a double track from Douglas to 13th street before this work is done. There is already a double track as far north as 2nd street, but most of the rails north of that are for dirt streets and are not high enough for a pavement, so that they will have to be replaced with new rails. ¶ A double track is also to be built on East Douglas from Hydraulic avenue to a point east of the drainage canal. Another project contemplated by the company is the building of the proposed line on North Waco from 9th street to 17th street. The rails now in use on Topeka will be used on this line. Mr. Morrison also says that as soon as the new concrete bridge across the Arkansas river is completed, some double track will be built on West Douglas avenue and Maple street to admit of two places for cars to pass on the West Side of the river and thus reduce the service to nine minutes. These double tracks would be from the river to Sycamore and from Seneca to Martinson or Elizabeth on Maple.

8. The Orient Railway is paving its driveway east of its freight depot, at southeast corner of Douglas and Mosley, with paving brick laid on concrete base. The space being paved is 40 feet wide and 150 feet long, extending the entire length of the freight building. Approximate cost of this improvement is \$2000. A platform 30 feet wide and 90 feet long, south of the freight depot, has just been completed.

The Orient railway has been receiving much new rolling stock. Within the last ten days, 619 pieces of new rolling stock costing over \$700,000 have passed through Wichita en route to points on the Kansas and Oklahoma division. They included 400 new box cars, 200 new stock cars, two "Jim Crow" cars, two combination baggage and mail cars, and fifteen engines. The 400 box cars were built by the American Car and Foundry company, St. Louis, and cost \$800 apiece. The 200 stock cars were built by the same company and also cost \$800 each. Because of a recent Oklahoma law requiring that the railroads provide compartment cars for negroes, the railway purchased the "Jim Crow" cars, with a partition in the car reserving one-fourth of the space for negroes. This section is finished in plush. The rest of the coach, for white persons, is finished with white rattan seats. The cars are lighted with incandescent lights. These day coaches cost \$6800 each and were made by the American Car works, St. Louis. ¶ The combination baggage and mail cars, from St. Charles, Missouri, cost \$7000 each and passed through Wichita Saturday. ¶ The fifteen new 140 ton locomotives are from the American Locomotive Works, Patterson,

New Jersey, and cost \$17,000 each.

7. There will be no extension of the Midland Valley Railroad during the present year.

Article says the suit recently begun against the Wichita Railroad and Light company by J. S. Corley and others to prevent it from changing its line from Rutan to Hillside was to have been heard in district court today, but was settled out of court at the request of the plaintiffs. The franchise granted by the city council for the line on Hillside stipulated that it should be built before October 1, 1907, but work has been delayed by the injunction suit so long that it will now be necessary to obtain an extension of the time from the council.

6. The new seven story Caldwell-Murdock building will soon be ready for occupancy. Most of building is already leased. Tenants listed. Details.

The "owl" cars on five of the street car lines were discontinued last night, and it is said by the company that they will not be resumed until there is business enough to justify it. Henceforth the last cars for College Hill, West Side, South Emporia, South Main, and Riverside will leave Main and Douglas at 11:48 p.m. This cuts off twelve minutes from the leaving time of the last cars on these lines, which for several months have been leaving Main and Douglas at 12 o'clock. The latter will continue to be the last hour at which the North Main and Topeka cars will run.

7. Brick is being placed on the ground for the new Coler Sim building at 1st and Market streets.

Lumber has been received by the Orient railway with which to build a platform west of the depot for the use of passengers arriving and departing on the Orient.

According to the new plans a considerable part of the foundation will have to be torn away. ¶ The new plans and speculations were made by E. L. Masqueray, a church architect of St. Paul, Minnesota. They have arrived here and await approval by Bishop Hennessy. ¶ When a new cathedral was first planned over three years ago, the estimated cost was \$150,000. Accordingly Architect Charles Conradi, architect of many fine world's fair buildings, drew plans, which were accepted, and work commenced on the structure. ¶ About a year ago when the foundation had been completed, even the optimistic Conradi admitted that it would cost more than \$150,000 to complete the cathedral. He was called to account, and the investigation showed clearly that with his plans and speculations the final cost would probably exceed \$250,000. Accordingly work was at once stopped. ¶ The new plans call for a different style structure, which will be as large and pretentious as the Conradi plans although not on as expensive lines. The large clock that was to appear in the tower of the Conradi structure is not seen in the new plans. ¶ The large granite pillars, eight in number, which are to mark the entrances, remain in the back part of the church property. ¶ With acceptance of the plans by Bishop Hennessy, work will resume on the delayed cathedral.

It will be torn down to make room for a modern building. ¶ For years "Uncle John" used this building, the ugliest, unsightliest, most forlorn looking shack in the city, for cleaning, storing, and handling grain, after which it was loaded on board the cars for transit to Galveston, New York, or other ports. ¶ At a meeting of the creditors of the Miltner Grain company yesterday, it was decided to tear down the old building and put the six lots on which it stands upon the market. It is expected that the sale of the property will pay all debts left by Mr. Miltner.

the employ of the government at his trading post at the Kiowa and Comanche agency six miles from Ft. Sill. I was here supplying him with goods in 1868 and 1869 and attending to transportation. All this time the quarter section adjoining mine on the east laid vacant, so in the latter part of July 1869 I staked and held it for Mr. Mathewson and made the necessary improvements to hold it for him, which at that time consisted of a notice of location written on a board stuck in the ground, four logs laid as a foundation, breaking half an acre of ground, and registering a notice with Mr. D. S. Munger of the Munger hotel, who kept records of all claims taken, was postmaster, hotel keeper, etc. Mr. Mathewson knew nothing of my taking the claim for him until I wrote him later. ¶ Now about the log house being the first house built in Wichita. Mr. Mathewson came up over the Chisholm trail in the spring of 1870 from his trading post at Ft. Sill, bought a set of hewed logs up the Little river, moved them onto his claim, and made a comfortable home for his family, whose residence was at Topeka. How could his carpenters have helped build the Munger house when that hotel had been completed and open to the public for eighteen months at that time? There was also the Buck Horn (sic) tavern, a number of stores and other places of business in the town of Wichita, about a mile distant from the Mathewson claim (latter bounded by present day Washington, Central, Hydraulic, and Douglas avenues)." Says he has been doing business on the site of Wichita since 1863.

The advertisement says there are no floating debts on the company and that the gross earnings for the current year up to October 5 show an increased of \$49,401.51 over the same period in 1907. The net earnings are three and a half times the bond interest. After paying all operating expense and interest on the bonds last year, the company had a net profit left over of practically \$80,000 (90,000). With the \$225,000 from the sale of its bonds, the yield in ready cash was \$315,000.

Chubbuck was installed as general manager of the Illinois Traction company and of the Western Railway and Light company. He will take active charge of these companies from January 1 and from then make his home in Peoria, Illinois.
