## **Literary Rights**

## **Content Note**

This collection contains material written and collected by WSU alumnus Leslie Robert Bloom with respect to his unfinished master's thesis on the Industrial Workers of the World (IWW) and its presence in early 20<sup>th</sup> century Kansas. Items include drafts of Bloom's thesis, correspondence, copies of academic publications and IWW literature, press clippings, an interview transcript, federal agency and bureau reports, and assorted research notes. Inclusive dates are from 1910 to 1992.

## **Administrative History**

The Industrial Workers of the World, an international labor union, was founded in Chicago, Illinois, on June 27, 1905. Since its inception, the IWW's purpose has been to unite all wage-earning laborers for the purpose of overthrowing capitalism and the wage labor system, thereby bringing about an economic state of affairs in which laborers cooperate in the means of production. The union's headquarters are still in Chicago.

The IWW became prominent during World War I due to its stances against conscription and various economic and political policies enacted by the federal government after America declared war on Germany on April 6, 1917. In September of that year, dozens of union members were arrested in Chicago, Wichita, San Francisco, and other locations for their alleged activities against the draft and

the Espionage Act of 1917, along with other charges. Following a months-long delay, C.W. Anderson and others arrested in Kansas were tried and found guilty in federal court on various counts and sentenced to imprisonment in Leavenworth in December 1919. Following an appeal which reversed the federal court's ruling on a charge of sabotage, as well as requests by various parties for amnesty, all of the imprisoned IWW members were pardoned or granted commuted sentences by the end of 1923.
