The Bell collection spans the years of 1967 to 1971.

Biography

Donald Alfred Bell was born July 13, 1928 in Wichita, Kansas. A lawyer, he represented District 68 in 1965, 1966, and Special Session 1966 and District 79 in 1967, 1968, 1969, 1970. He was Majority Floor Leader in 1969. He was married to Eleanor Harriet Van Gleson. On November 12, 1985, he died from injuries received in airplane crash.
