This collection contains newspaper clippings dealing with E. W. Patterson's career as a Kansas Congressman and his political campaigns, 1930-1938. The collection also contains various souvenirs and autographs from Patterson's colleagues.

Biography

E. W. Patterson was born October 4, 1895, in Pittsburg, Kansas. After graduating from Pittsburg High School in 1914 he attended the Kansas State Teachers College. In 1917 he served with the 35th Division of the A.E.F. in France. After graduating from the University of Kansas Law School in 1922, Patterson practiced law in Pittsburg. He became active in politics in 1922 when he campaigned for the Democratic ticket in Crawford County, Kansas. In 1926 he was elected County Attorney of Crawford County. Patterson won the Congressional seat for the Third District in Kansas in 1932. He was reelected 3 times to this position. Patterson was married to Leah Kennedy and
