## **Content Note**

SNUPPS is comprised of a group of power generating organizations: Kansas City Power & Light Company, Kansas Gas & Electric Company, Northern State Power Company, Rochester Gas & Electric Company, and Union Electric Company. The collection discusses aspects of nuclear generated power. Volume I deals with site characteristics, design of structures and system components, reactor construction, and the reactor coolant system. Volume II discusses engineered safety features, reactor controls, and the generation of electric power. Volume III is concerned with radioactive waste management and radiation assurance. Volume IV discusses possible radioactive contamination with an examination of accidental analysis and quality assurance and Volume V is comprised of revisions.
