#### **Content Note**

This collection contains 15 letters written to Myra McHenry during the years 1900 to 1907. The correspondents include Carry A. Nation, A. T. Ayres, Lucy Wilhite, J. C. Rogers and McHenry's son Cornell McHenry. The chief subject of the letters is temperance; however, several include personal matters.

### **Biography**

An activist in the early temperance movement in Kansas, Myra McHenry (1848-1939) staged street corner lectures, published a newspaper and many pamphlets, and was arrested frequently for her aggressive tactics.
