#### Content Note

Charles Grafly was an American sculptor whose works include monumental memorials and portrait busts. Dating from the late 19th and early 20th centuries, his correspondence relating to personal, business and other matters is collected here as well as newspaper clippings about his works, sketches and class notes, scrapbooks, photographs of his works, research materials and glass plate negatives. All file folder titles reflect the original titles of the file folders in the collection. For a detailed description of the contents of each file folder, refer to the original detailed and incomplete finding aid in Box 76.

#### Biography

Born and raised in Philadelphia, Charles Grafly (1862-1929) studied under painters Thomas Eakins and Thomas Anshutz at the Pennsylvania Academy of Fine Arts between 1884-88. Grafly then enrolled at the Academie Julian under the sculptor Henri-Michel Chapu (1833-91). Sculpture at the Academie was dominated by a Beaux-Arts style, characterized by its use of allegory, mythological themes, and aesthetics reminiscent of classical Greek sculpture. Grafly had three years of successful study before returning to Philadelphia in 1892, where he accepted a job as instructor of modeling at

the Pennsylvania Academy of Fine Arts. Grafly worked primarily in public commissions, completing prestigious monuments such as the Pioneer Mother Monument, 1915, in San Francisco and the Memorial to Major General George Gordon Meade, 1927, in Washington, D.C. His better-known works include "Fountain of Man," "From Generation to Generation," "Symbol of Life," "Vulture of War" and many portrait busts
