### Content Note

The James R. Mead Collection of papers consists of business materials, personal correspondence, biographical materials, memorabilia and photographs. The largest part of the collection is James R. Mead's business papers, which includes trading post ledgers from the 1860s to 1880s, bills for goods and supplies purchased from other merchants, and correspondence with partners and associates. Much of Mead's business correspondence was with William Mathewson while he was in Fort Sill, Indian Territory. Later correspondence concerns Mead's involvement in the railroad, the First National Bank of Wichita, and various state organizations. The collection contains several diaries kept by Mead as he traveled as well as manuscripts written later in life about his remembrances of Kansas Territory. In addition to business correspondence, this collection contains Mead's personal correspondence with other members of his family. The collection contains a large collection of family photographs, memorabilia, and newspaper clippings. Also included in the collection is correspondence with other members of the Mead family, which ranges from Rev. Enoch Mead's letters (1830s) to Ignace Mead Jones' letters (1980s). Also included is a series of photographs taken

by Fern Mead Jordan in 1927, when a grass lodge was reconstructed on Mead Island by members of the Wichita Tribe.

## Biography

James R. Mead (1836-1910) was born in New Haven, Vermont, to Rev Enoch and Mary E. (James) Mead. The family soon moved to Davenport, Iowa. James Mead had one younger sister, Elizabeth (Lizzie), who never married. Mead attended Iowa College in Davenport (1849-50) after which he was employed at McKarty Mill in Davenport. Mead enjoyed hunting and traveling, which he did a lot of over the next years. His letters and journals reflect his interest in both activities. In May 1859, Mead began his journey westward to Kansas Territory. Once in Kansas he established several trading posts. The first was the Salina Ranch near present day Salina and later posts were located at Towanda (1863), between the Little and Big Arkansas Rivers (1864), along the Ninnescah River (1865) and at the Round Pond Creek (1866). During this time Mead was actively hunting and trading with the Indians and he became acquainted with William Greiffenstein, William Mathewson and Jessie Chisholm as well as other famous persons.

In 1861, he married Agnes Barcome. They had four children, James L. (Bunnie), Elizabeth Agnes (Lizzie), Mary E. (Mamie) and J. William, who died in infancy. Agnes died in 1869. Mead was married in 1873 to Lucy Inman, who had been his housekeeper. She died in 1894 and two years later Mead was married for the third time to Fern Hoover. They had two children, Ignace and Loreta.

Throughout his adult life Mead was involved in many business ventures and Kansas politics. He was elected to the Kansas House of Representatives in 1864 and to the Kansas Senate in 1868, where he was appointed chairman of the Ways and Means Committee. In business, Mead actively promoted Wichita and played a role in moving the railroad to the town. He also was involved in the First National Bank of Wichita until its failure in 1876. Other business ventures include the cattle business, real estate, farming and mining in Colorado. In later years Mead became involved in the Academy of Sciences and the Kansas State Historical Society, serving in leadership positions in both organization. During later years, Mead also recorded many of his memories of the early days in Kansas in the form of manuscripts and short articles. His articles were published in the *Collections of the Kansas State Historical Society*, *Scientific American*, *Transactions of the Kansas Academy of Sciences* and various newspapers.

Leavenworth; contains receipts of goods bought by JRM from Leavenworth merchants to set up a trading post; contains a copy of the treaty with the Cheyenne and Arapaho (October 14, 1865) during which William Mathewson acted as interpreter; contains several other treaties made at this time with the Indians (1865); contains a receipt of payment; contains letter to JRM from the Land Office in Humboldt, Kansas (December 30, 1865) and a certificate for filing a claim [photocopy of the letter also included]. Contains a claim slip, (December 27, 1864) Section 17, Township 26, Range 4.

Spencer and JRM will trade with the Kaw Indians [article found in a billfold]; contains a quit-claim deed from Joab and Mary Spencer to JRM (September 10, 1867).
