The Andrew Jacobs, Jr. papers covers his congressional correspondence with various federal departments from 1969 to 1970. These offices included Human Social Services, Post Office General, Veterans Administration and the Armed Services. The purpose for the correspondence was to instigate inquiries on the behalf of various Indiana constituents.

Biography

Andrew Jacobs, Jr., (son of Andrew Jacobs; husband of Martha Keys), a Representative from Indiana; born in Indianapolis, Marion County, Indiana, February 24, 1932; graduated from Shortridge High School, Indianapolis, Indiana, 1949; graduated from Indiana University, Indianapolis, Indiana, 1955; LL.B., Indiana University, Indianapolis, Indiana, 1958; United States Marine Corps, 1950-1952; lawyer, private practice; member of the

Indiana state house of representatives, 1959-1960; elected as a Democrat to the 89th and to the three succeeding Congresses (January 3, 1965-January 3, 1973); unsuccessful candidate for reelection to the 93rd Congress in 1972; elected as a Democrat to the Ninety-fourth and to the ten succeeding Congresses (January 3, 1975-January 3, 1997); was not a candidate for reelection to the 105th Congress in 1996.
