#### Literary Rights

#### Content Note

The Kantor Collection of the U.S. Sanitary Commission and Sanitary Fairs documents the activities of the U.S. Sanitary Commission and sanitary fairs to raise money and support for medical and humanitarian care for Union soldiers during the Civil War. The collection includes correspondence, financial appeals, ground plans, sheet music, broadsides, stereographs, lithographs, newspapers, and ephemera. More than two dozen sanitary fairs, which heavily relied on the volunteer efforts of women, were held between 1863 and 1865. They raised millions of dollars for the benefit of the U.S. Sanitary Commission and provided a way for civilians to contribute time, energy and money to show their support for the Union cause.

#### Administrative History

The United States Sanitary Commission and sanitary fairs represented one of the most successful democratic, humanitarian and philanthropic efforts in American history. The federally approved Commission evolved out of concerted efforts of private citizens who were alarmed at the lack of

medical support for the Union military forces in 1861. On the eve of the Civil War the military medical department lacked a plan, personnel, supplies and equipment for collecting wounded soldiers from the battlefield, transporting them to hospitals and caring for them there. President Lincoln acknowledged the situation and signed an executive order in June 1861 formally recognizing the volunteer group as the United States Sanitary Commission. Comprised of clergy, physicians and women, the Sanitary Commission worked both nationally and locally to raise money, educate the public about the reasons for supporting the war effort and organize the sanitary arrangements in camps and hospitals.

Initial fund raising efforts of the Commission were only marginally successful. In 1863 two managers of the Chicago regional office, Mary Livermore and Jane Hoge, organized the first grand sanitary fair in Chicago to raise money for the troops and build up civilian morale by encouraging greater citizen involvement in all aspects of the fair. She and the other fair organizers received donations of refreshments, goods for sale, displays of artwork and "curiosities," and offers to perform dramatic and musical entertainments. The fair raised more than \$78,000, an unprecedented sum, and garnered wide support from the public, resulting in "fair mania." Its success prompted other cities to organize similar events and many large cities, notably New York and Philadelphia, competed to stage fairs that featured ever more lavish pageantry.

Although initially reluctant to support these grand local fairs, members of the national Commission recognized their effectiveness and helped to organize and run sanitary fairs held in twenty cities throughout the North for the duration of the war. Estimates of total money raised for all the fairs vary from \$5 to \$7 million dollars as many citizens came to embrace the fairs as a patriotic vehicle to strengthen the Union and an acceptable diversion from the often depressing news from the front. The national Commission also worked hard to garner international support for the Union in Britain and western Europe and achieved some notable fund raising success among both British and European citizens as well as U.S. citizens living abroad.

Series 3	Box 2-Box 3	Music Song Sheets. Dated 1820 to 1865. Two bound books and twenty loose-leaf sheets. The bound books have pre-Civil War and Civil War songs, and are listed in order as bound. The theme of the loose-leaf sheets is the Sanitary Fair. The sheet music was written for different fairs, it varies from marches to polkas. Included in the series are two sheets of Confederate music. A great majority of the sheets are very fragile and in poor condition.

Series 4	Box 4	Large Broadsides. Contains an array of advertisements and announcements about different Sanitary Fairs. Included are lithographs that depict a variety of U.S. Sanitary Commission occupations.
Series 5	Box 5	Small Broadsides, Tickets, and Miscellaneous. Contains a variety of articles relating to different Sanitary Fairs. The small broadsides are announcements and public invitations. Included in the series are photographs, stereocards, and lithograph cards.
Series 6	Box 6, Box 9 FF 42	Newspapers. Contains assorted newspapers dating from 1861 to 1866 with articles related to the Sanitary Commission. The newspapers are arranged alphabetically throughout the box and arranged by date within each separate newspaper.
Series 7	Box 7, Box 9 FF 43-63	Miscellaneous Sanitary Commission Materials. Contains a variety of items including correspondence, supply registers, drafts, financial records, notes, reports and requisitions connected with the Sanitary Commission.
