#### **Content Note**

This collection of W. P. Fife's papers contains promotional information regarding investment securities and purchase of stock in the Great Western Oil Refinery and Pipe Line Company in Erie, Kansas, as well as in gold mines in Colorado. These sales circulars to potential investors urge investments in the refinery, and they represent the investment fervor surrounding the growing Kansas oil industry in the early 20th century. Also included are references for Fife and information about his business connections and career as an evangelist.
