Content Note

The F. Leroy Hill Papers extend from 1907 through 1981, and include his diaries, correspondence, business documents, personal papers, scrapbooks, artifacts, photographs and blueprints. The collection reflects Hill's career as an engineer, businessman, entrepreneur, and civic leader.

Of particular interest in the collection are the materials concerning Hill's association with Air Associates, Inc., 1928-1941. Air Associates was involved in airplane sales, service and repair, distribution of aviation supplies, and manufacturing of aircraft hardware and accessories. During his tenure at Air Associates, Hill held the positions of business manager, vice-president, and president, and remained with the company until the plant was seized on October 30, 1941, by President Franklin D. Roosevelt for Hill's refusal to sign a union contract. The collection contains a wide range of materials relating to the aviation industry and labor organization of the 1930s and 1940s.

Hill was involved in over 60 business entities, either financially or in a managerial position. His business interests were widespread and included participation in aviation, pharmaceuticals, oil, engineering design, machinery, and a

variety of other industries. A majority of the companies have materials in the collection with the bulk of business materials relating to Hill-Rockford Co. (previously named Hill Machine Co.). The Hill-Rockford Co. started as a tool, die, and contract shop, and then expanded to include the manufacturing of specialized machinery. The collection contains correspondence, business records, engineering articles, photographs of machinery, engineering sketches and blueprints which provide a detailed account of Hill's many business interests.

Hill's involvement in political and national issues began to take shape after his removal from Air Associates. He philosophically and financially supported a wide range of political organizations: The Mont Pelerin Society; the John Birch Society; the Foundation for Economic Education; the Liberty Lobby Committee of the U.S.A.; the Libertarian Party; and other economic and political organizations. The letters he exchanged with Congressman Leo Allen of Illinois, Congressman John B. Anderson of Illinois, and Senator Everett Dirksen of Illinois are rich in information relating to Hill's political concerns about the economy and the U.S. government.

The collection also contains numerous letters Hill wrote to friends, family members, and business leaders expressing his philosophical position on a wide variety of issues. Throughout his life, Hill enjoyed a number of close life-long relationships. The collection contains an extensive group of correspondence with Alice "Blue" Clemo, Ray Acres, Haven Page, Howard Hansell, Harold Crow, Dome Harwood, and family members. The correspondence discusses personal, business, political, and national issues, and it reflects the demeanor and character of Hill.

Biography

F. Leroy Hill, known as Leroy, was born July 16, 1894, in Huron, Michigan. He was the only son of Frank L. Hill Sr. and Nellie Potter Hill. Leroy's father, Frank Sr., was constantly searching for an employment opportunity that met his adventurous needs, and kept his family moving around the country. The 1906 San Francisco earthquake provided Frank Sr. with the opportunity and adventure he desired, and finally the family had a permanent home.

Hill's entrepreneurship and engineering aptitudes became apparent at an early age. He was a hard worker and began earning his way early on. At first, he earned money by helping his mother with household chores, and he soon graduated to his own newspaper route. In order to earn additional funds, Hill began delivering coal and firewood to local homes in the San Francisco area, an arduous job considering the heavy loads he had to carry up and down the hills. In San Francisco, Hill had a workshop at the back of his home where he built and designed electric motors, a wireless radio, and various other mechanical devices. His friends learned at an early age of Hill's engineering skills when he built an electric-shock machine and dared them to hold onto the conducting rods for as long as possible.

Upon graduating from Berkeley High School in 1912, Hill began searching for an engineering job. He wanted to work for the Hall-Scott Motor Company but, at first, he was turned down. Nevertheless, Hill persisted in seeking employment from the company, and was finally offered a job by Hall-Scott on January 29, 1913. Hill realized that a college education was necessary for his career, and he entered the University of California at Berkeley in 1913. He continued to work at Hall-Scott Motor Company and at his engineering education until the United States entered World War I. On the first day, after the United States' declaration of war, Hill enlisted as a regular seaman with an application pending for officers' training in aviation.

Unfortunately, Hill did not hear from the Navy after his enlistment, except for a letter which directed him not to leave the 12th Naval District. While he waited for his call to duty, Hill completed his senior thesis for his bachelor's degree in engineering. During this time, Hill was charged with establishing a course in airplane instruction and demonstration for the Army Air Corps' ground school at the University of California at Berkeley. Hall-Scott engines and other various engines were provided to him, and he wrote instructional materials to demonstrate how the engines operated.

In the meantime, Al Hall, President of Hall-Scott Motor Company, was put in charge of designing and building the new 12-cylinder engine for airplanes. Hall asked Hill to join his staff and help design the new engine. On April 6, 1918, Hill received orders to immediately report for duty at the Boston Naval Headquarters. Nevertheless, Hill's Navy career was short-lived. Al Hall needed Hill to continue his work on the Liberty 12 engine, and Hall was able to get Hill discharged from basic training and sent back to Dayton, Ohio to continue his work. Unfortunately, Hill never returned to basic training in the Navy as he had hoped and spent the rest of the war working for Al Hall.

After World War I, Hill held a variety of jobs including a few of his own entrepreneurial adventures. Although Hill wanted to return to the aviation industry, his dream did not become reality until 1928, when Ray Acres, a longtime

friend, recommended Hill to the company that was to be Lockheed Aviation's new eastern distributor. The company was Air Associates, a airplane sales and equipment distribution company. Hill began working for Air Associates in 1928, and the company grew and expanded rapidly.

By 1938, Hill had been promoted to president of the company. In this year, Air Associates had their first encounter with labor unions, specifically the C.I.O. At first a small group of Air Associates' employees organized and tried to get an exclusive bargaining contract with the company. Hill and the company refused to sign the C.I.O. contract, and when the Air Associates dismissed a few employees for undesirable behavior, the C.I.O. filed charges with the National Labor Relations Board (NLRB). (The NLRB was established by the National Labor Relations Act, or Wagner Act, to negotiate and settle labor problems.)

After the 1938 dispute was settled, the union activity in the Air Associates' plants was minimal until 1941. In 1941, Air Associates relocated its headquarters to Bendix, New Jersey. On June 17, 1941, a C.I.O. representative approached Air Associates' management and demanded a union contract be signed by the company. The company refused but agreed to a general election for union representation. At this point, events began to escalate rapidly. On July 3rd, Air Associates laid off nine men in the sheet metal department because of an aluminum shortage. On July 8th, the C.I.O. presented its contract to the company, and before any negotiations could take place, the C.I.O. called a strike because of the nine men that had been laid off. Air Associates refused to bargain with the strikers, and on July 17th, the strike turned violent. The N.L.R.B. intervened and, through mediation, settled the strike by July 22, 1941.

Though the immediate problem had been settled, Hill and the company still refused to bargain with the C.I.O. By October, the situation was strained, and on October 23, 1941, 2,000 to 3,000 picketers descended upon Air Associates. Due to Hill's hard-line position against the unions, Franklin D. Roosevelt, President of the United States, ordered the seizure of all Air Associates' plants on October 30, 1941. The conditions established by the war department for the plants' return to company control was the removal of Hill as president and the removal of Vice-President Harold Crow. On November 19, 1941, the Board of Directors of Air Associates removed Hill as president of the company.

While at Air Associates, Hill met his second wife, Ellen Mayo Hill. Over the next ten years, the couple would observe the birth of five daughters: Ellen (Nellie), 1942; Marcia, 1944; Holly, 1945; Elizabeth, 1949; and Isabella, 1952. Shortly after his removal from Air Associates, the United States entered World War II. Hill, and his family moved to Rockford, Illinois, where Hill established various small companies that supplied aviation parts to the U.S. government. By the end of the war, Hill was established as an entrepreneur.

Hill's entrepreneurial abilities began to expand after the end of the war. In 1945, Leroy started the Hill Machine Co., later renamed the Hill-Rockford Co. This company was to become the focal point of his life, and he remained in control of the company for the rest of his life. Although Hill-Rockford Company was the primary business entity, Hill invested in or manage numerous other companies: Aldrich Co.; Polo Pump Co.; Rystrom Engineering; Syncro Flame, Inc.; The Walter E. Selck Co.; Vance Industries; Ponder Oil Ltd.; and many others.

After the 1940s, Hill began to focus more attention on the political and philosophical issues that affected his life. Throughout the 1950s and 1960s, Hill wrote his congressmen on a regular basis, expressing his concern about the role of government and other national issues. Besides writing to his congressmen, Hill also contributed financially to various political organizations, although his primary interests were organizations concerned with the economy and economic issues. In addition to his correspondence concerning political organizations and issues, Hill also wrote letters expressing his support and concern to business leaders who were faced with labor problems similar to those he encountered at Air Associates.

Hill led a long and adventurous life. Although he was forced to slow down after a stroke in 1976, he continued to express his opinion and to lead a full life until his death in 1981 at the age of 87. There is no single word that can accurately describe the life and beliefs of F. Leroy Hill. Perhaps the best description of his life came from his wife, Ellen. In 1992, while Dr. Craig Miner was preparing to write Hill's biography, Ellen Hill commented "that her husband was a happy man, secure in what he believed to be right."

Chronological Business Biography

The following is a summary of the jobs and ventures in which Hill was a major participant, including salaried employment, corporations, and individual promotions. The information obtained for this summary was written by Hill in June, 1974. The list is in chronological order. An asterisk after the date indicates that further information and materials are contained in the collection. From this point on in this guide, Hill will be referred to by his initials,

FLH, and Air Associates will be known as AA.

1912-17 *

Hall-Scott Motor Car Company, Berkeley, California. The company designed and manufactured engines. FLH worked for the company as a draftsman, machinist, and general assistant.

1917 *

J. L. Hicks Marine Engine Company, San Francisco. The company designed and manufactured marine engines. FLH tried to take over the company by promoting investors, but the venture was unsuccessful.

1917

FLH set up airplane engine instruction and demonstration course for Army Aviation Ground School at University of California at Berkeley.

1917-18 *

During World War I, FLH worked for Al Hall, President of Hall-Scott Motor Car Company, designing the four-cylinder Liberty engine and 12-cylinder Liberty engine for airplanes.

1919

Berkeley, California. Designed slow speed heavy marine engine with FLH's friend, Harold Crow. Wrote prospectus and tried to find backer.

1919 *

Hewitt-Ludlow Motor Truck Co. The company manufactured and designed engines. FLH was employed as its chief engineer.

1919 *

A. H. Coates Co., San Francisco. The company was a manufacturers' distributorship for automotive products. FLH was employed as a sales engineer.

1919-20 *

Adam-Hill Co., San Francisco. The company was a distributorship for automotive products. FLH and Pete Adam, bookkeeper at A. H. Coates Co., started partnership.

1920-21 *

F. Leroy Hill, Engineering and Sales Representative. FLH began this company after separating from Pete Adam. The company was a distributorship of automotive products.

1921 *

Motive Products Co, San Francisco. The company was a partnership with Harold Crow, expanding the lines and sales of the above company.

1921-22 *

Duo Disc Steel Wheel Co., Los Angeles and Maywood Illinois. The company manufactured and sold steel disc wheels for the Ford Model T. FLH acted as the company manager.

1922

Lincoln-Light Midwest Co., Omaha, Nebraska. The company was a partnership with Harold Crow for the distribution of Lincoln-Light farm lighting plants in four states.

1922-23

Lincoln-Light Corp, Grafton, Wisconsin. The company manufactured and designed farm lighting plants. FLH worked for the company as a factory manager.

1924*

Radio Units, Inc., Maywood, Illinois. The company manufactured loop aerals and dial adjusters. FLH was employed by the company as its factory manager.

1924-28 *

Bodine Electric Co., Chicago, Illinois. The company manufactured and designed electric motors. FLH was employed as an engineer with the company.

1927

Hill-Crow Co., San Francisco, California. The company was a renewed partnership for engineering and sales with Harold Crow. The company never formed because FLH accepted a job with Air Associates (AA).

1928-41 *

Air Associates, Inc. The company sold airplanes, serviced airplane engines, distributed aviation supplies and accessory equipment, and manufactured aircraft hardware. FLH held the positions of business manager, vice president, and president.

1930-39 *

Jesco Lubricants, Inc., Kansas City, Kansas. FLH invested in a company that was promoting a special lubrication material.

1933 *

Magmatic Minerals, Inc., Washington, D.C. FLH invested in company that was making synthetic diamonds.

1937

Spencer-Larson Aircraft Co., Garden City, New York. FLH invested in a company that designed and manufactured amphibian aircraft.

1940-41 *

Aircraft Standard Parts Co., (No. 1) Rockford, Illinois. The company was a small joint venture for special aircraft screw drilling operation.

1942-74 *

Cotta Transmission Co., Rockford, Illinois. FLH invested in a joint venture. The company manufactured and designed gears and transmissions.

1942-44 *

Hill-Bartelt Machine Co., Rockford, Illinois. The company was a partnership between FLH and Harold Bartelt. The company designed and manufactured thread mills and other machinery.

1942-45 *

Aero Screw Co., Rockford, Illinois. FLH began this company that manufactured and sold aircraft hardware.

1942-47 *

Aircraft Standard Parts Co., (No. 2), Rockford, Illinois. This company was a family partnership which manufactured hose clamps, turnbuckles, and other airplane parts.

1943-44

Econo Mfg. Co., Chicago, Illinois. This company was set up to share sales of Aero Screw Co. and Aircraft Standard Parts Co.

1943-44

Ferra Mfg. Co., Rockford, Illinois. Same as above.

1943-44

Midland Mfg. Co., Rockford, Illinois. Same as above.

1943-44

Drill Mfg. Co., Rockford, Illinois. Same as above.

1943-44

Pinion Gear Co., Rockford, Illinois. Same as above.

1943-45 *

Threaded Products Co., Rockford, Illinois. FLH formed this company that produced screws for Aircraft Standard Parts Co. hose clamps.

1943-45 *

Machine Salvage Co., Rockford, Illinois. FLH formed this company to buy and sell used machinery.

1944-45 *

Texarkana Supply Co., Dallas, Texas. This company was a partnership designed to establish a supply-jobbing business.

1944-46

Rock River Screw Machine Products Co., Rockford, Illinois. This company was a partnership designed to manufacture hose clamp screws.

1944-50

F. L. Hill Mfg. Corp., Inc., Rockford, Illinois. FLH formed this company as a personal holding company for the investment and management of his various projects.

1944-49 *

Polo Pump Co., Polo, Illinois. The company manufactured oil burner pumps. The started as Rystrom Engineering Co., and FLH invested in and managed the company.

1945-74 *

Hill Machine Co., Rockford, Illinois. (Later renamed Hill-Rockford Co.) FLH formed this company which started as a tool, die, and contract shop and later manufactured and designed specialized machinery.

1947 *

Aldrich Co., Wyoming, Illinois. The company manufactured oil burners and boilers. FLH promoted the sale of Aldrich to the Breeze Corporation and acted as the company's general manager for nine months.

1951-68 *

Building - 610 East State St., Rockford, Illinois. FLH bought and managed building.

1953-56 *

Lanolin Plus, Inc., Chicago, Illinois. FLH invested in this company which manufactured cosmetics.

1954-74 *

Duplex Dwelling - Ellen Avenue, Rockford, Illinois. FLH purchased building and land which he leased to Rockford Memorial Hospital.

1954-55 *

Neutronics, Inc., Detroit, Michigan. FLH invested in company which manufactured a chrome processing equipment.

1954-56 *

Camdale, Inc., Detroit, Michigan. FLH invested in company that manufactured and designed precision cams and gears.

1954-56 *

Bellanca Aircraft Co., Newcastle, Delaware. FLH invested in company that manufactured aircraft equipment.

1954-58 *

Syncro Flame, Inc., Walworth & Delavan, Wisconsin. FLH invested in company that manufactured oil and gas burners.

1954-68 *

Walter E. Selck & Co., Chicago, Illinois. FLH invested in company that manufactured floor coverings and sink frames.

1955-56 *

State Pharmacal Co., Chicago, Illinois. The company manufactured cosmetics. FLH invested and promoted stock exchange between Lanolin Plus and State Pharmacal Co.

1955-60 *

McAlear Mfg. Co., Chicago, Illinois. FLH invested in company that manufactured valves and fittings.

1955-71 *

North Towne Plaza, Rockford, Illinois Shopping Center. FLH invested in stock in the shopping plaza.

1955-74 *

Vance Industries, Inc. Chicago, Illinois. FLH invested in company that manufactured sink frames and floor coverings.

1956-57 *

Chicago Leasing Service, Chicago, Illinois. FLH invested in real estate company.

1956-60 *

Skillman Hardware Co., Trenton, New Jersey. FLH invested in building-hardware manufacturer.

1956-64 *

Graphic Arts Trust, Chicago, Illinois. FLH and others purchased building in Detroit and resold building to the Church of Religious Science in Los Angeles.

1958-60 *

Laurel Bloomery Mines, Bristol, Tennessee. FLH invested in a joint venture of a manganese-mining operation.

1959 *

Vinco, Inc., Detroit, Michigan. FLH promoted the purchase and merger of Vinco by Selck & Co. in order to establish an AMEX listing for Selck & Co.

1959-60 *

Commercial Trades Institute, Chicago, Illinois. FLH invested in correspondence school for TV repair, air conditioning repair and other trades.

1959-64 *

Lamb Industries, Inc., Toledo, Ohio. FLH invested in company which manufactured water heaters and other products.

1959-73 *

Ponder Oils, Ltd., Calgary, Canada. FLH invested in petroleum exploration and production company.

1964-66 *

Assets Equipment Co., Inc., Rockford, Illinois. FLH invested in machinery- leasing company.

1964-73 *

Tollway Properties, Chicago, Illinois. FLH invested in joint venture to purchase and sell 1500 acres of land on N.W. Tollway in Chicago.

1966-72 *

Harwood & Co., Francestown, N.H. FLH invested in partnership of small contracting business.

Detailed Description: Series Listing

Series 1	Box 1-2	Diaries, February 1, 1906 - July 7, 1913; January 1, 1918 - August 6, 1922; January 1, 1942 - December 31, 1977. Included in this series are both original diaries and photocopied diaries. The diaries contain a listing of F. Leroy Hill's daily personal and business activities, including meetings, dinner invitations, social activities and short personal entries. In general the entries do not include substantial information or private evaluation. When known, the location where the diary was written is mentioned, and efforts were made to include description of significant entries. Arranged chronologically.
Series 2	Box 3-17	Correspondence, 1918 - 1977. The correspondence series contains personal, business, and political correspondence. The series is arranged as received. Box 3, 1918 - 1942, is arranged by subject and then chronologically. Box 4 and part of Box 5 are arranged chronologically. All files after 1942, Boxes 5-17, are arranged chronologically in alphabetical order. The titles of the original files have been underlined in the file description. Note: F. Leroy Hill (FLH) maintained files both at home and at his office. Correspondence, especially business correspondence, can be found in the Correspondence series and the Business Documentation and Correspondence series.
Series 3	Box 18-46	Business Documentation and Correspondence, 1918-1980. The business documentation and correspondence series

contains correspondence, financial statements, annual records, business records, legal documentation, engineering and business articles, photographs, engineering sketches, blueprints, and catalogs. The series is arranged in chronological order according to a report written by FLH which describes his business activities throughout his life. A listing and brief description of the companies found in the collection has been added to the finding aid.

Series 4	Box 47-48	Personal Materials. The personal material series contains unpublished writings, political conference materials, publications, manuscripts, blueprints, and engineering articles. The contents of this series are files that were placed separately from other materials in the collection. The materials are of personal importance to FLH and reflect his many interests and life.
Series 5	Box 49	Photographs. The series contains a few oversized photographs and sketch of FLH at various stages of his life.
Series 6	Box 50-54	Scrapbooks. This series consists of five scrapbooks which contain photographs, advertising and promotional material, press releases, engineering articles, and newspaper articles. Four of the scrapbooks are for companies with which FLH was associated: Aero Screw, Air Associates, Hill Machine Co., and Hill-Rockford Co. The remaining scrapbook contains articles and photographs of airplanes built during World War II by various countries.
Series 7	Box 55	Artifacts, Oral Interviews, and Biography. This series contains personal memorabilia from FLH's life and taped interview with Ellen Hill by Susan K. Hess, October 10, 1995.
Series 8	Oversized Storage	Oversized Materials. The oversized series contains encapsulated materials that were originally located in other files. The original location of these items are designated in the individual file folder descriptions.
