

Dr. Edward N. Tihen (1924-1991) was an avid reader and researcher of Wichita newspapers. His notes from Wichita newspapers -- the "Tihen Notes," as we call them -- provide an excellent starting point for further research. They present brief synopses of newspaper articles, identify the newspaper -- Eagle, Beacon or Eagle-Beacon -- in which the stories first appeared, and give exact references to the pages on which the articles are found. Microfilmed copies of these newspapers are available at the Wichita State University Libraries, the Wichita Public Library, or by interlibrary loan from the Kansas State Historical Society.

Saturday, October 24, 1908

12. Drawing of the W. S. Henrion "double apartment house" now being finished at corner of Topeka and Murdock. Cost \$7000.

Wednesday, March 10, 1915

4. Annual meeting of stockholders of the Riverside Club was held yesterday and a good year is expected. W. S. Henrion was re-elected president. Harry Stanley was elected vice-president and Frank Dunn, treasurer. The club has now about 250 members, with a limit of 400. Details.

Thursday, January 4, 1917

4. The Riverside Club has closed its doors because of financial difficulties. The directors decided last week to quit business January 1. The club has a bonded indebtedness of \$18,000. Its property on River Drive (sic) near 11th Street is valued at \$20,000. A year ago the District Court was asked to appoint a receiver for the organization, but the dissatisfied creditors were appeased. President Walter Henrion said today that the club would be reorganized and reopened within a short time.

Wednesday, March 14, 1917

5. The Riverside Club, which closed several months ago because it was out of money, is to be reorganized soon and reopened for the spring and summer seasons. President Walter S. Henrion today said that plans are being perfected and the directors will take action on the matter within a week.

6. Board of Regents of Wichita University yesterday let contract for drawing of plans: for new science hall to Schmidt, Boucher, and Overend; for addition to Henrion

Gymnasium to Glen Thomas; and for the new heating plant to Ed Forsblom. Details.

Sibbitt, who died fourteen months ago, and the stock was sold by his widow, Mrs. Clara Sibbitt and by Walter S Henrion, of Henrion Improvement Company.
