

Dr. Edward N. Tihen (1924-1991) was an avid reader and researcher of Wichita newspapers. His notes from Wichita newspapers -- the "Tihen Notes," as we call them -- provide an excellent starting point for further research. They present brief synopses of newspaper articles, identify the newspaper -- Eagle, Beacon or Eagle-Beacon -- in which the stories first appeared, and give exact references to the pages on which the articles are found. Microfilmed copies of these newspapers are available at the Wichita State University Libraries, the Wichita Public Library, or by interlibrary loan from the Kansas State Historical Society.

Thursday, March 14, 1912

3. Louis R. Hurd, president of the Red Star Mill company, has leased for three years the house at 1215 North Emporia built originally by the sons of John G. Carlisle, who was secretary of the treasury during Cleveland's last administration. The property belongs to Mrs. David B. Walker and was the home of her father, the late W. W. Johnston, who founded the Johnston-Larimer Dry Goods company.

1. L. R. Hurd, president of the Red Star Mill and Elevator Company, today purchased the H. J. Hagny residence at northwest corner of Belmont and Broadview for \$36,000. Mr. Hagny built the home three years ago when there were few improvements in that part of the city.

1. Report of marriage today of Allen W. Hinkel to Mrs. R. Given Hagny in the study of the First Presbyterian Church at Newton, Kansas. Details. Attending were the bride's mother, Mrs. J. O. Davidson, and her brother, J. O. Davidson, Jr., as well as Nancy Hagny, daughter of the bride. ¶ They will reside in the L. R. Hurd home at 401 North

Belmont, which was built by H. J. Hagny, brother of the late R. Given Hagny, and later purchased by Mr. Hurd. After Mr. Hurd's death, Mrs. Hurd moved to Minneapolis and placed the home up for sale.

1. The L. R. Hurd residence at 3rd and Belmont has been purchased by the Wichita Art Association and will be converted into a permanent art gallery and school. Details.

- 9B. The former Wichita Art Association building at 401 North Belmont has been sold to Mr. and Mrs. Bernard H. Kastens and will be remodeled and used as a residence. The Art Association had owned the property, formerly the L. R. Hurd home, since 1942. Another part of the property, the former Culver residence, located north of the school, at 424 North Broadview (?), was sold about six months ago to Mr. and Mrs. Howard K. Pierce, who moved into the home last November. Mrs. Pierce is the daughter of Wichita artist C. A. Seward, one of the Art Association's founders.
