Dr. Edward N. Tihen (1924-1991) was an avid reader and researcher of Wichita newspapers. His notes from Wichita newspapers -- the "Tihen Notes," as we call them -- provide an excellent starting point for further research. They present brief synopses of newspaper articles, identify the newspaper -- Eagle, Beacon or Eagle-Beacon -- in which the stories first appeared, and give exact references to the pages on which the articles are found. Microfilmed copies of these newspapers are available at the Wichita State University Libraries, the Wichita Public Library, or by interlibrary loan from the Kansas State Historical Society.

### Tuesday, August 24, 1920 page

Was raised on a farm and commenced the practice of law in Illinois at age 21. Came to Wichita in 1879 (actually 1880) and in fall of 1880 was elected county attorney of Sedgwick County and re-elected in 1882. ¶ After eight years as District Court Judge he practiced in partnership with Samuel B. Amidon in the firm of Dale and Amidon until 1912, when he retired. Since then he has been on the examining board, appointed by the Supreme Court of Kansas, for examination of lawyers for admission to the **bar**, and in the past several years has been chairman of that board. ¶ He married Louise Berry, of Paw Paw, Lee County, Illinois in 1882. They have resided at 933 North Waco for a number of years. ¶ Other survivors are three brothers, Arthur H. Dale, of Leland, Illinois, Judge Frank Dale of Guthrie, Oklahoma, and J. W. Went to Medicine Lodge and started practice. Elected state senator from there in 1889, and was in U.S. Senate 1903 to 1909. Moved to Wichita after retiring from Senate. In 1925 was president of the American **Bar** Association. ¶ Married Miss Anna Nache in Paola on February 12, 1895. She died December 10, 1919. Survived by three daughters, Mrs. Harry F.
